Section 4.3 Schedule of Development-Owner to prioritize Block 3 Low Density Residential ("LDR") Units-this area Block 3A started home construction in 2024 and is being developed now. Owner required to average 100 units per year retroactively between July 1, 2020-June 30, 2025 for a total of 500 units. This was completed.

Section 5.4 RV Parking-Owner contracted with a third party to provide for 50 RV Parking spaces at College Park Community.
