<b>July 13 - August 7, 2026</b>	Filing Period for Nomination Papers and Candidate's Statements
<b>August 5 - November 3, 2026</b>	24-hour Contribution Report (Form 497) Filing Period for Contributions of \$1,000 or more made/received from a Single Source.
<b>August 7, 2026 at 5:30 pm</b>	Last Day to File Nomination Papers Last Day to Withdraw Declaration of Candidacy and Nomination Papers
<b>August 10, 2026 at 5:00 pm</b>	Last Day to Withdraw Candidate's Statement
<b>August 12, 2026 at 5:30 pm</b>	Last Day to File Nomination Papers - Extended Filing Period if incumbent has not filed
<b>August 13, 2026</b>	Secretary of State to Determine the Order of Names on the Ballot
<b>August 21, 2026</b>	City Clerk to publish Notice of Nominees
<b>September 7, 2026 - October 20, 2026</b>	Filing Period for Write-in Candidates
<b>September 19, 2026</b>	First Day Political Signs may be Posted
<b>September 24, 2026</b>	Last Day for Filing Campaign Expenditure Statements (1 <sup>st</sup> Pre-election Statement)
<b>October 19, 2026</b>	Last Day to Register to Vote
<b>October 22, 2026</b>	Last Day for Filing Campaign Expenditure Statements (2 <sup>nd</sup> Pre-election Statement)
<b>November 3, 2026</b>	<b>ELECTION DAY:</b> Polls are open from 7:00 a.m. to 8:00 p.m.
<b>November 3, 2026 at 8:05 PM</b>	<b>ELECTION DAY:</b> Election results posted for mail ballots received from the USPS at 8:05 p.m. and mail ballot drop-off locations prior to election day. Results updated every 2 hours until election night counting is complete.
<b>November 13, 2026</b>	Last Day to Remove Political Signs
<b>December 3, 2026</b>	Registrar of Voters to Issue Statement of Results
<b>December 15, 2026 or a special meeting called for this purpose.</b>	City Council to Declare Election Results and Installation of Elected Officials (date dependent upon receipt of the certification of election results by the Registrar of Voters).
<b>February 1, 2027</b>	Last Day for Filing Campaign Expenditure Statements (Semi-Annual Statement)
