Council Member Burton asked staff to provide a report to inform residents that California's drought continues and urged water conservation.

NEW BUSINESS

18. Memorandum of Understanding with City of Ontario for Storm Drain Line I. Approve a Memorandum of Understanding with the City of Ontario for the financing and construction of Storm Drain Line I.

Jesus Plasencia, PE, Assistant City Engineer provided a report on the item. He shared the MOU outlines the cost share for Line I for City of Chino at 58%, or \$29.58M, and City of Ontario's share would be 42%, or \$21.42M, for a total project cost of \$51M.

City Attorney Galante provided an overview on the water law requirements that protect historic water flows.

Mayor Ulloa requested staff negotiate cost shares with the San Bernardino Flood Control District and ensure the City does not incur the bulk of the fees. Mr. Plasencia stated he believes there is an opportunity for the San Bernardino Flood Control District to agree to the proposed cost shares.

Council Member Lucio noted there are ongoing new development projects in this area that include new infrastructure, sewer drains, roads, along with Chino Airport who is also responsible for the runoff that comes into the City of Chino. He asked Staff to clarify if San Bernardino County will participate in the cost share to help fund the project. Mr. Plasencia explained this project is to be considered a regional facility serving more than one agency and there is confirmation of runoff coming from both City of Chino and City of Ontario and the fees would be shared.

Mayor Pro Tem Comstock stated this project has been studied in detail by all impacted parties and while she does not support the proposed fees, she is in support of how Staff has designated this project as a regional project. She noted the commitment with all the entities involved to provide the necessary funding and expressed gratitude to the Staff for their efforts. Mayor Pro Tem Comstock noted that this project is greatly needed to help address the flooding experienced in our community and added that construction costs are not likely to decrease in the future.

Council Member Lucio asked staff to identify the funding source and provide a timeframe estimate to generate the funds, should the County decide not to fund half of the money needed for this project, and Mr. Plasencia confirmed staff are actively looking for grant and bond opportunities and noted that this is a long-term project that will be built over time. He confirmed the City has the funds to construct a portion of the storm drain and Staff will continue to seek additional funding for the remainder of the project. Mr. Plasencia explained there is a portion of the storm drain that is located south of Pine Avenue that outlets to the Prado basin that will require jurisdictional approval from the Orange County Flood Control District and Army Corps of Engineers that will be a long-term project.

Mayor Pro Tem Comstock asked staff to provide an update on whether the City's application as a regional project has been accepted, and Mr. Plasencia indicated the acceptance notification is anticipated to be received in early 2024. Mayor Pro Tem Comstock requested staff to report back to the City Council with the progress of this project.

Moved by Council Member Burton, seconded by Council Member Comstock, to 1) Approve a Memorandum of Understanding with the City of Ontario for the financing and construction of Storm Drain Line I; and 2) authorize the City Manager to execute the necessary documents on behalf of the city.
