**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO,
CALIFORNIA ADOPTING THE 2016 LOCAL HAZARD MITIGATION
PLAN UPDATE, AUTHORIZING FUTURE NON-SUBSTANTIVE
AMENDMENTS TO THE PLAN, AND RESCINDING RESOLUTION
NO. 2011-048**

WHEREAS, the preservation of life and property is an inherent responsibility of local, state and federal government; and

WHEREAS, the City of Chino joined with agencies in San Bernardino County to develop, adopt, and maintain a Local Hazard Mitigation Plan; and

WHEREAS, the City is charged and entrusted with the protection of persons and property prior to and during emergencies, and/or disaster conditions; and

WHEREAS, the goal of a Local Hazard Mitigation Plan is to minimize, reduce, or eliminate loss of life and/or property; and

WHEREAS, the Local Hazard Mitigation Plan represents a comprehensive description of the City's commitment to reducing, preventing, or eliminating potential impacts of disasters caused by natural and human-caused hazards; and

WHEREAS, the City of Chino previously adopted its Local Hazard Mitigation Plan with the adoption of Resolution No. 2011-048; and

WHEREAS, the City Council desires to rescind Resolution No. 2011-048 and adopt the updated 2016 Local Hazard Mitigation Plan in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, the City has undertaken a comprehensive planning effort in developing the Local Hazard Mitigation Plan by organizing resources, assessing risks, and developing and implementing a mitigation plan and monitoring process; and

WHEREAS, a Local Hazard Mitigation Plan is a Federal requirement under the Disaster Mitigation Act of 2000 for the City to receive Federal funds for disaster recovery and mitigation; and

WHEREAS, the Local Hazard Mitigation Plan established a coordinated effort to support mitigation activities, and identifies measures to combat natural and man-made hazards within the City; and

WHEREAS, the Local Hazard Mitigation Plan is an extension of the State of California Multi-Jurisdictional Local Hazard Mitigation Plan and will be reviewed and exercised periodically and revised as necessary to meet changing conditions; and

WHEREAS, the City of Chino agrees to adopt the 2016 Local Hazard Mitigation Plan and urges all officials, employees, public and private organizations, and citizens, individually and collectively, to do their share in furthering the goals and objectives of hazard mitigation within the City of Chino.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHINO DOES HEREBY RESOLVE, DETERMINE, AND ORDER AS FOLLOWS:

SECTION 1. Resolution No. 2011-048 is hereby rescinded.

SECTION 2. The City Council approves the 2016 Local Hazard Mitigation Plan Update of the City of Chino.

SECTION 3. The City Council authorizes the Director of Emergency Services, or his duly appointed representative, to make necessary administrative and operational changes to the plan that are in keeping with the intent of the plan as approved.

SECTION 4. The City Council authorizes the Director of Emergency Services, or his duly appointed representative, to perform all duties required to carry out the Local Hazard Mitigation Plan.

SECTION 5. That the City Clerk shall certify as to the adoption of this resolution.
