**FEDERAL UPDATE (Item 1)**

**Federal Budget**

On July 1, 2025, the U.S. Senate passed President Trump’s tax and spending reconciliation package, which encompasses most of the President’s legislative agenda. The final vote was 51–50, with Vice President JD Vance casting the tie-breaking vote.

The House passed the bill on July 3 by a vote of 218-214.

President Trump signed the bill into law during the July 4th picnic on the White House grounds.

The legislation extends President Trump’s 2017 tax cuts and significantly increases funding for immigration enforcement and national defense. To fund the increased spending, the bill imposes reductions to domestic programs, including cuts to Medicaid and food assistance of \$1.2 trillion, as well as billions from federal higher education funding. According to estimates from the Congressional Budget Office, the bill will increase the national deficit by \$3.3 trillion over the next decade and result in 11.8 million additional people losing health coverage. **Education Funding**

The U.S. Department of Education (ED) announced that it was withholding FY 2025 Congressionally approved funding for several federal education programs, including:

- Title I-C for migrant education (\$375 million)
- Title II-A for professional development (\$2.2 billion)
- Title III-A for English-learner services (\$890 million)
- Title IV-A for academic enrichment (\$1.3 billion)
- Title IV-B for before- and after-school programs (\$1.4 billion)
- Adult basic and literacy education (\$729 million)

The FY 2025 funding for these federal programs is still under review, according to the President’s Administration. Funding was to be sent to state educational agencies on July 1st, in advance of the new school year.

### **STATE LEGISLATIVE CALENDAR – Recent and Upcoming Legislative Deadlines**

- July 18 - Last day for policy committees to hear and report bills. Summer Recess begins upon adjournment, provided Budget Bill has been passed.
- Aug. 18 - Legislature reconvenes from Summer Recess.
- Aug. 29 - Last day for fiscal committees to hear and report bills to the Floor.
- Sept. 2-12 - Floor session only. No committees may meet for any purpose, except Rules Committee, bills referred pursuant to Assembly Rule 77.2, and Conference Committees.
- Sept. 5 - Last day to amend on the Floor.
- Sept. 12 - Last day for each house to pass bills. Interim Recess begins upon adjournment.
- Oct. 12 - Last day for Governor to sign or veto bills passed by the Legislature before Sept. 12 and in the Governor's possession on or after Sept. 12.
