### **NEW BUSINESS**

13. Professional Services Agreement to Dudek to prepare the City's Urban Forest Management Plan. Award a Professional Services Agreement to Dudek to prepare the City's Urban Forest Management Plan (MS260).

Staff Report By: Michelle Chapman, CIP Engineering Manager

RECOMMENDATION: Award a professional services agreement to Dudek for \$245,377.00 to prepare the City's Urban Forest Management Plan (MS260); and authorize the City Manager to execute all necessary documents on behalf of the City.

Hye Jin Lee, Director of Public Works, introduced the item, and Michelle Chapman, CIP Engineer Manager, provided a presentation on the item.

Stubbie Barr, provided a public comment regarding the "Tree City" designation status, the relationships with developers, and the replacement of trees when construction conflicts exist. He noted the proposed inventory will help establish proper oversight on communities with HOA's who have the responsibility to maintain their trees.

Mayor Pro Tem Burton spoke regarding the program and discouraged the use of trees that drop sap and pine needles, or trees that tend to have frequent broken branches.

Council Member Lucio noted developers of new construction will remove young trees that are damaged by the high winds and not replace them. He recommended the use of trees that can potentially withhold heavy winds.

Mayor Ulloa recommended the development standards be updated with fire prevention language to prohibit trees that can easily catch on fire, such as pine and palm trees. She also requested to prohibit pepper trees as they break and are frequently damaged.

Council Member Comstock spoke regarding trees generating flowers or sap and recommended some conventional wisdom related to the maintenance of trees. She expressed she is a proponent of trimming trees aggressively.

In response to whether or not our current tree maintenance company was considered, Ms. Chapman explained West Coast Arborists have been limited to providing tree maintenance and tree inventory services to the City. The Dudek firm who received the highest score in the bidding process will develop the forest management master plan. Ms. Lee shared that Dudek specializes in creating master plans and the tree selection recommendations shared will be included in this plan.

Mayor Pro Tem Burton asked when a tree is removed can a mature tree be planted, and Ms. Lee confirmed that this requirement can be incorporated into the municipal code.

Council Member Flores stated commercial property owners have expressed concern regarding trees that have uplifted commercial parking lots and recommended the master plan include trees that cause minimal damage and require low maintenance costs in commercial centers.

Stubbie Barr, shared that the City's Municipal Code contains a tree replacement schedule and lists the box tree size, noting the time frame the trees have been in the box causes them to be root bound.


