RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO, CALIFORNIA, APPROVING MEMBERSHIP IN THE CALIFORNIA INTERGOVERNMENTAL RISK AUTHORITY (CIRA) AND PARTICIPATION IN THE LIABILITY AND WORKERS' COMPENSATION PROGRAMS

WHEREAS, pursuant to the provisions of the Government Code commencing with Section 6500, the City of Chino ("City") wishes to enter into an agreement with the California Intergovernmental Risk Authority ("CIRA") for the purposes of pooling the Liability and Workers' Compensation coverages as more fully set forth in the Joint Powers Agreement; and

WHEREAS, said Liability and Workers' Compensation Programs offer significant advantages to the City justifying the City's participation in such programs on the conditions set forth, and is in the best interest of the City; and

WHEREAS, the Deposit Premium is based on a payroll estimate of \$66,718,061.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Chino;

Section 1. That the City hereby authorizes the City Manager to execute the Joint Powers Agreement on its behalf with the effective date of July 1, 2025;

Section 2. Liability Program. That the City hereby consents to participate in said Liability Program on the conditions that:

- (a) The City hereby selects its self-insured retention (SIR) of \$1,000,000 which represents the City's responsibility per occurrence.
- (b) This City's Premium for liability coverage as provided by CIRA is estimated to be \$1,569,784;

Section 3. Workers' Compensation Program. That the City hereby consents to participate in said Workers' Compensation Program on the conditions that:

- (a) The City hereby selects its self-insured retention (SIR) of \$500,000 which represents the City's responsibility per occurrence.
- (b) This City's Deposit Premium for coverage as provided by CIRA is estimated to be \$362,351;

Section 4. Board Representative Designation. The City hereby designates the Director of Human Resources/Risk Management as its representative on the CIRA Board of Directors, to act on all matters coming before said Board on behalf of the City as a Member Entity, as if the City itself were present. The City designates the Deputy Director of Human Resources/Risk Management as the alternate representative.

Section 5. The City is hereby authorized to pay to CIRA the amounts identified in Section 2 and Section 3 above for Liability and Workers' Compensation coverage.
