A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO, CALIFORNIA, ADOPTING AND AMENDING PORTIONS OF RESOLUTION NOS. 85-52, 85-53, AND 85-54 PERTAINING TO COMPENSATION FOR EMPLOYEE POSITION CLASSIFICATIONS REPRESENTED BY PART-TIME EMPLOYEES

WHEREAS, the City Council of the City of Chino adopted Resolution Nos. 85-52, 85-53, and 85-54 and subsequent resolutions to establish changes to salaries, benefits, and terms and conditions of employment for City classifications, including those represented by Part-Time Employees; and

WHEREAS, the wages, hours, and terms and conditions of employment of affected employees are codified in a variety of City Resolutions, Summaries of Benefits, and Agreements; and

WHEREAS, the latest Summary of Benefits for Part-Time Employees covering the period of July 1, 2025 through June 30, 2027 ("PART-TIME EMPLOYEES 2025-27") was approved and adopted by Resolution No. 2025-039; and

WHEREAS, the City has determined that changing the implementation schedule of the cost of living wage adjustments for Part-Time Employees would be in the best interests of the City and the parties; and

WHEREAS, the City has determined the updating the Sick Leave cap for Part-Time Employees from 48 hours to 80 hours in accordance with the Healthy Workplace, Healthy Families Act would be in the best interests of the City and the parties; and

WHEREAS, it is the desire of the City Council of the City of Chino to approve and adopt an amended PART-TIME EMPLOYEES 2025-27 Summary of Benefits to memorialize and confirm the change in the implementation schedule of the cost of living wage adjustments and update the Sick Leave cap from 48 to 80 hours.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF CHINO, CALIFORNIA, DOES HEREBY RESOLVE AS FOLLOWS:

<u>SECTION 1</u>. The foregoing recitals are true and correct and are incorporated herein by this reference.

<u>SECTION 2</u>. The City hereby approves and adopts an amended PART-TIME EMPLOYEES 2025-27 Summary of Benefits, which is attached hereto as Exhibit A.

<u>SECTION 3</u>. In the event of conflict between this Resolution and any prior City resolution relating to the subject matter thereof, this Resolution shall supersede and prevail over the prior resolution to the extent of the conflict. To the extent of this Resolution provides benefits in excess or is different from the benefits provided in Resolution No. 2025-039, the provisions of this Resolution shall control.

<u>SECTION 4</u>. The City Clerk shall certify the adoption of this Resolution effective November 4, 2025.
