**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO  
APPROVING A SUBSTANTIAL AMENDMENT TO THE CITY OF CHINO'S FY  
2024-25 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL  
ACTION PLAN**

**WHEREAS**, the City Manager's Office of the City of Chino is proposing a Substantial Amendment to the City of Chino's Annual Action Plan and budget for FY 2024-2025; and

**WHEREAS**, the proposed amendment will reallocate \$298,868.65 in FY 2024-25 CDBG funding as follows:
