RESOLUTION OF THE CITY OF CHINO ACCEPTING THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR THE SUSTAINABLE TRANSPORTATION PLANNING (STPG) GRANT AND AUTHORIZING THE CITY MANAGER, OR HER DESIGNEE TO EXECUTE THE STPG GRANT AGREEMENT

WHEREAS, The City of Chino is eligible to receive Federal and/or State funding for certain transportation planning related plans, through the California Department of Transportation (Caltrans); and

WHEREAS, a Restricted Grant Agreement is needed to be executed with Caltrans before such funds can be reimbursed through the Transportation Planning Grant Program

WHEREAS, Caltrans awarded the City of Chino STPG grant funds in the amount of \$500,000 for development of the Chino Active Transportation Plan Project through a competitive “Call for Projects”; and

WHEREAS, the City Council desires to accept \$500,000 of Sustainable Transportation Planning Grant Funds; and

WHEREAS, the City Council desires to amend the FY 2026-27 CIP Budget by creating a new project, “Chino Active Transportation Plan,” Project No. MS275 and establish Grant #G7270; and

WHEREAS, the City Council desires to amend the FY 2026-27 CIP Budget by appropriating \$500,000 of STPG grant funds and \$64,780 in Measure I “Local Match” funds for a total budget amount not to exceed \$564,780 to “Chino Active Transportation Plan,” Project No. MS275; and

WHEREAS, The City of Chino wishes to delegate authorization to the City Manager, or their designee, to execute these agreements and any amendments thereto;

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Chino accepts the \$500,000 of Sustainable Transportation Planning Grant Funds and authorize the City Manager, or her designee, to execute all Restricted Grant Agreements and any amendments thereto with the California Department of Transportation.
