The February 4, 2025, Regular Meeting of the City Council / Successor Agency to the Redevelopment Agency was called to order at 5:31 pm by Mayor Eunice M. Ulloa in the Council Chambers.

NEW BUSINESS

6. <u>Introduction of Ordinance No. 2025-001.</u> Approve the Introduction of Ordinance No. 2025-001 Amending Chapter 8.12 of the Chino Municipal Code Pertaining to Fireworks.

Staff Report By: Silvia Avalos, Director of Community Services, Parks & Recreation

RECOMMENDATION: Approve the Introduction of Ordinance No. 2025-001, to be read by number and title only, waiving further reading of the ordinance, amending Chapter 8.12 of the Chino Municipal Code (CMC) pertaining to fireworks.

Silvia Avalos, Director of Community Services, Parks & Recreation (CSPR), provided a presentation on the item.

Mayor Ulloa called upon the public comments received from the audience.

Karlee Remender, representing Don Lugo Performance Arts/Band Booster, spoke in opposition of the ordinance, as presented.

Aiden Flores, spoke in opposition of the ordinance, as presented.

Tony Flores, representing the parents of Troop 202 and Chino High School Band Booster, spoke in opposition of the ordinance, as presented. He suggested a central location be established in the City of Chino for drop off of unsold fireworks.

John Kelly, TNT Fireworks, provided an introduction, spoke in opposition of the ordinance, as presented. He offered to work together on alternate solutions.

Mayor Ulloa asked if there were any additional requests to speak from the audience.

Bobby Martinez, community member, spoke against the firework vendor's decision to require non-profit organizations to pay a \$1,500 merchandise pickup fee, and advocated for exploring other vendor options.

Neal Jerry, CSPR Commissioner, spoke in support of the ordinance, as presented.

Donna Marchesi, spoke in opposition of the proposed item.

Hearing no additional requests to speak, Mayor Ulloa requested Council Member comments.

Council Member Comstock asked Staff when the fireworks wholesaler representatives were notified of the CSPR Fireworks Subcommittee recommendations. Both Ms. Avalos and Nikki Love, Strategic Initiatives Manager, confirmed the wholesalers were notified approximately two weeks before the January CSPR Commission meeting. Ms. Love confirmed TNT and Phantom representatives had no questions at the time of notification.

Council Member Comstock asked if TNT and Phantom were the only fireworks providers in Chino, and Ms. Love confirmed currently they are the only two wholesalers being utilized.

Mayor Pro Tem Burton clarified the current distribution and collection practices of fireworks stock, and expressed concerned regarding the fireworks wholesaler fees.

City Attorney Galante confirmed the Chino Municipal Code has a provision that requires wholesalers to secure a permit, and it could be amended to include language that will obligate

the wholesaler to pick up the fireworks stock by a specified date or provide a central drop off location within the City.

Council Member Lucio discussed the practices of other city programs and suggested the City conduct an RFP process in order to ensure transparency and offer multiple options to the stakeholders.

Council Member Flores asked how many non-profits have contracted with TNT this year, and Ms. Avalos explained the number is unknown, noting the City application is scheduled to be sent on February 14, 2025.

Mayor Ulloa explained she preferred the non-profits handle the negotiations with the vendors, however, she acknowledged the City might need to get involved to help develop a solution through revising the ordinance. She suggested delaying the ordinance introduction approval until the next meeting.

Mayor Ulloa asked staff to consider alternate solutions, and invited Council Member Comstock to serve as a liaison for the City Council as Staff reviews the ordinance.

Council Member Flores expressed concern regarding the application start date. Ms. Avalos explained staff is required to issue applications on February 14, 2025, however, the applications are not due until March 14, 2025, allowing time to make changes before the applications are due.

Council Member Comstock recommended applications should contain language to advise all applicants the ordinance is currently under review by the City Council.

Assistant City Manager Melendez confirmed staff will proceed with the current application process and existing regulations will continue to apply, and the recommended changes will be tabled, reviewed, and re-introduced at the next meeting.

The item was pulled and returned to City staff for further review. It is anticipated to be returned for City Council consideration at the next regular meeting on February 18, 2025.

Police Chief Mensen thanked Run for Russ participants, the Public Works Department, and the Kiwanis Club for their support, and spoke regarding the Police Department's efforts related to traffic safety.

Director's Report

Hye Jin Lee, Director of Public Works, provided an update on the windstorm recovery; announced residents north of Chino Avenue are asked to conserve water from February 12-25 due to possible water service interruptions related to the Metropolitan Water District works on the Rialto feeder pipeline, she also noted the City has secured additional water sources from the City of Ontario and Upland if needed; announced CalRecycle will be conducting audits from February 3-6, as part of their Flip the Lid Program to survey for recycling of organics, but no tickets will be issued; and reported on the City's efforts to deter illegal dumping with the installation of signage, cameras and flood lights in some alleys, and partnerships with Code Enforcement and the Police Department have been established to help prosecute offenders.

Fire Chief Dave Williams announced the Chino Valley Fire District Administrative Office front counter will be closed on Fridays, however, appointments still can be made in advance by the end of the business day on Wednesdays.
