

RESOLUTION NO. 2025-067

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CHINO APPROVING A SUBSTANTIAL AMENDMENT TO THE CITY OF CHINO COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL ACTION PLAN FOR FISCAL YEAR (FY) 2022-2023.

WHEREAS, the City of Chino is proposing a Substantial Amendment to the City of Chino's CDBG Annual Action Plan 2022-23 and adopted FY 2025-26 CDBG program budget; and

WHEREAS, the proposed amendment will transfer \$31,500 in CDBG program funds as outlined in the table below:
