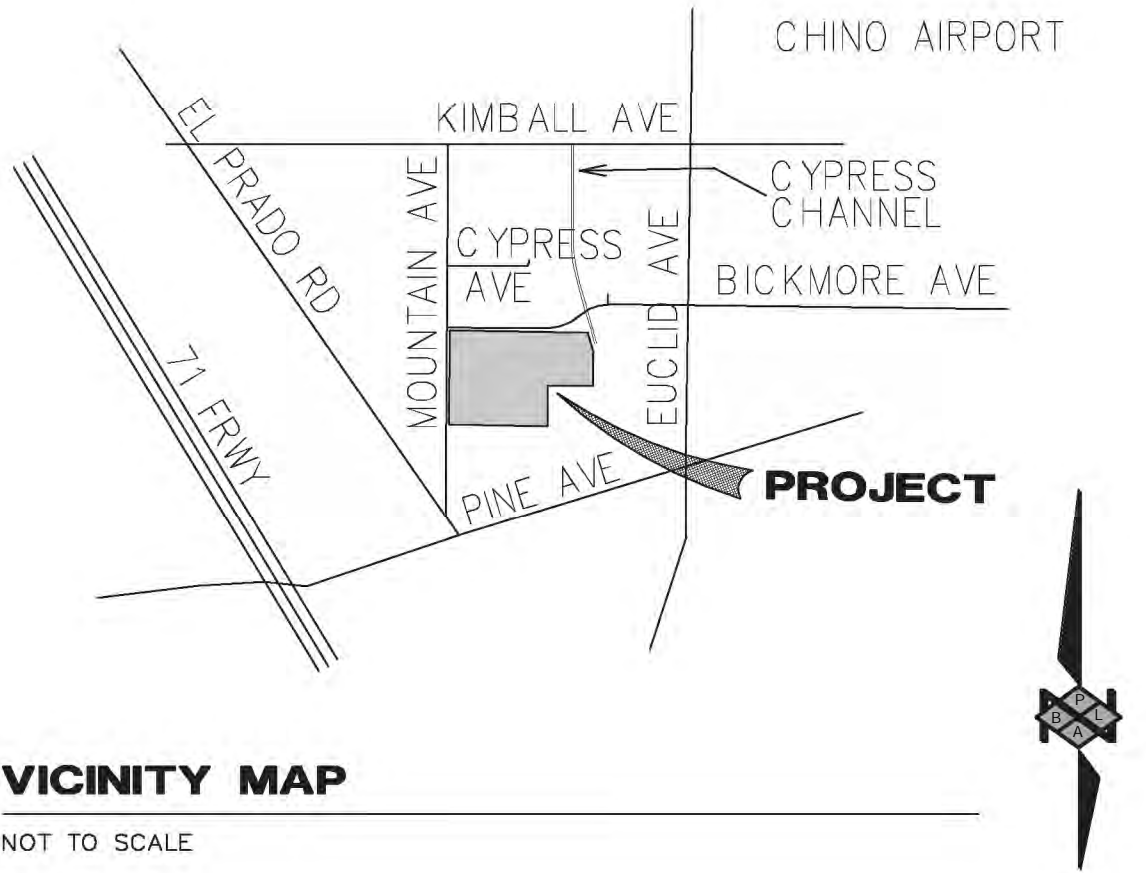

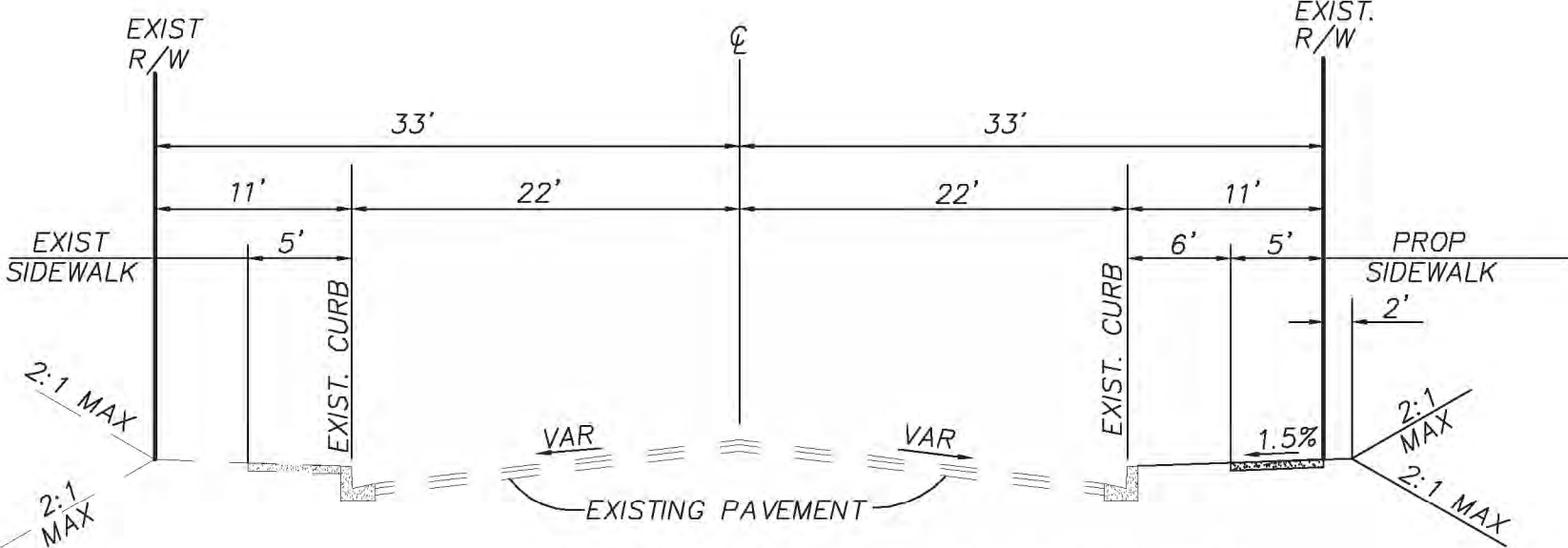

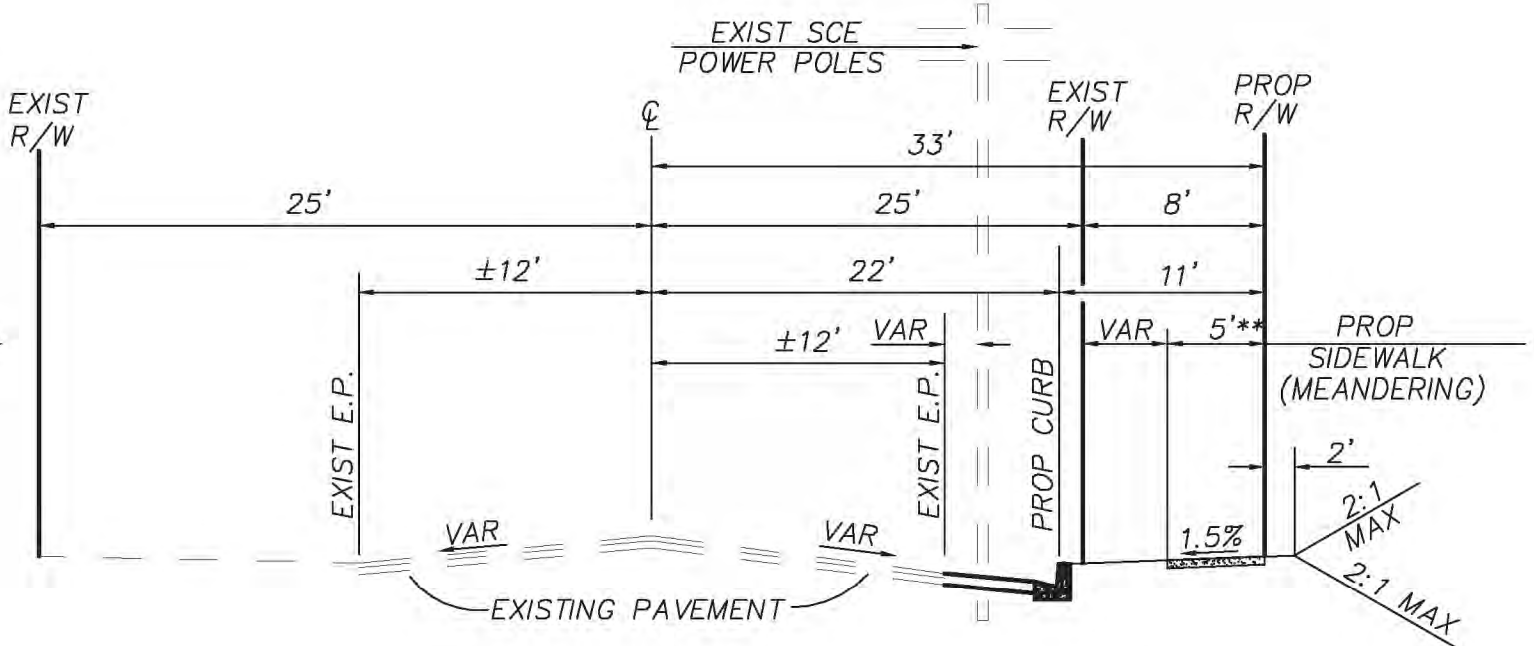

FROM 212' SOUTHERLY OF BICKMORE FOR FRONTAGE REMAINDER

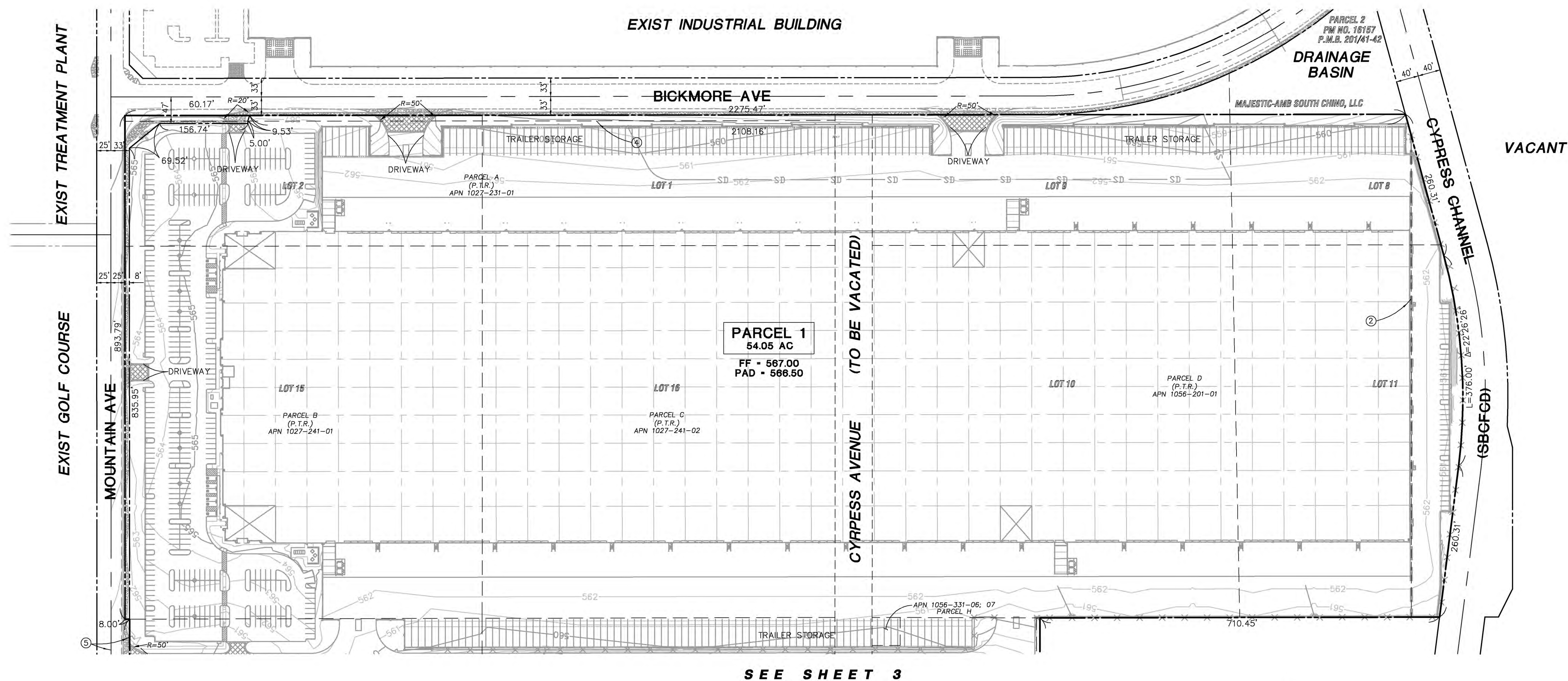
